CatchAToken Terms of Use

Please read these Terms of Use ("Terms") carefully before using the CatchAToken Telegram bot ("Service" or "Bot"). These Terms form a binding agreement between you ("User," "You," or "Your") and CatchAToken ("Company," "We," "Us," or "Our"), the operator of the Service accessible via Telegram and related websites (e.g., www.catchatoken.com).

By accessing or using the Service, including any subscription features or affiliate program, you agree to be bound by these Terms. If You do not agree, do not use the Service. We may update these Terms at any time, and continued use constitutes acceptance of changes. Notifications of material changes will be posted in the Bot or on our website.

1. Interpretation and Definitions

- Account: Your unique profile in the Bot for accessing features like tracking and subscriptions.
- Referral System: The 3-level referral system described in Section 7.
- **Content**: Any data, text, or information You interact with via the Service.
- **Tracked Accounts**: X (formerly Twitter) users or Telegram channels monitored via the Service.
- Subscription: Paid access tiers granting limits on tracked accounts.
- You/User: The individual or entity using the Service.

2. Acknowledgment and Eligibility

- You must be at least 18 years old and capable of forming a binding contract.
- Your use must comply with all applicable laws, including privacy and antispam regulations.
- By using the Service, You also accept our Privacy Policy (<u>www.catchatoken.com/privacy</u>).

3. User Accounts and Responsibilities

- You are responsible for the security of your Account.
- You may not:

- Use the Service for illegal purposes or in violation of Telegram or X.com rules.
- o Reverse-engineer, hack, or disrupt the Bot.
- Create multiple Accounts to abuse trials or referrals.
- Spam, harass, or misuse tracked data.

Permitted Use of Forwarding:

 You may forward Bot notifications to your direct messages, groups, or channels for personal use, community engagement, or to earn referral commissions via your links.

Prohibited Uses:

- You may **not** create, sell, or operate another bot, platform, or paid service that mirrors, republishes, or automates redistribution of CatchAToken notifications.
- You may not charge others for access to Bot-generated notifications or present them as originating from another service.
- Misuse of forwarded content, including cloning or competing services, is grounds for termination.

4. Service Description and Features

- The Service enables tracking of X accounts and Telegram channels for updates (e.g., tweets, reposts, replies, profile changes, channel updates).
- Notifications appear in one Bot window for convenience.
- The Service may evolve (e.g., browser extension, expanded integrations) and these Terms apply to all future features.
- The Service is provided "as is," and we do not guarantee 100% accuracy or uptime.

5. Subscriptions and Payments

- Subscription tiers range from Starter (10 accounts, \$30/month) to Elite (250 accounts, \$200/month) and Group (100 accounts, \$500/month).
- Discounts: 3 months (10%), 6 months (20%), 12 months (30%).
- Fiat payments made through Telegram Stars (via Apple Pay, Google Pay, debit/credit cards, or other locally available methods) are non-refundable, except where required by law (e.g., the EU 14-day cooling-off period).

- Cryptocurrency Payments are non-refundable
- Accepted payment methods:
 - Cryptocurrency (USDT, USDC, TON, TRX, BTC, ETH, LTC, BNB) via Telegram Wallet.
 - Referral Account Balance.
 - Telegram Stars via Apple Pay, Google Pay, debit/credit cards, or other locally available methods.
- You are responsible for any applicable taxes.

6. Intellectual Property and Competition

- The Service, code, designs, and trademarks are owned by Us or licensors.
- You are licensed to forward Bot notifications for your own use and referral activities.
- Creating a competing paid service or automated redistribution tool using Botgenerated content is prohibited.
- Do not copy, modify, or distribute Our IP without permission.

7. Referral Program

- Eligibility: Available to Users with Accounts who are at least 18 years old.
- Structure:
 - Level 1 (Direct Referrals): 10% (0–29 referrals), 20% (30–99), 30% (100+).
 - Level 2: 7% fixed.
 - Level 3: 5% fixed.
- Group Subscriptions are excluded from referral rewards.
- Referral statistics are pseudonymized; we do not share usernames, phone numbers, or personal identifiers.
- Obligations: You must promote ethically, disclose affiliate links, and avoid spam or misleading promotions.
- Violations may lead to termination and forfeiture of commissions.

8. Termination

- You may terminate your Account at any time.
- We may suspend or terminate Accounts for violations, non-payment, or misuse.
- Upon termination: access ends; eligible unpaid commissions are settled within 60 days.

9. Limitation of Liability

- The Service is provided "as is" without warranties.
- We are not liable for indirect damages (e.g., lost profits, data).
- Our liability is limited to fees paid in the last 12 months.

10. Indemnification

You agree to indemnify Us against claims arising from Your misuse of the Service, violations of these Terms, or misuse of forwarded Content.

11. Governing Law and Disputes

- These Terms are governed by the laws of Poland.
- Disputes shall be resolved through arbitration.
- EU Users retain applicable consumer rights.

12. Miscellaneous

- Force Majeure: We are not responsible for events outside our control.
- Severability: Invalid provisions do not affect the rest.
- No Token Policy
- CatchAToken does not issue or manage any cryptocurrency tokens.
- We do not permit or endorse any third party to create tokens representing our brand, nor do we collect fees, royalties, or trading revenue from such tokens.
- Any claims of an "official CatchAToken token" are false. Users should avoid engaging with such offerings.
